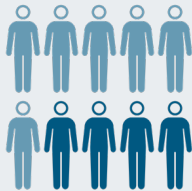
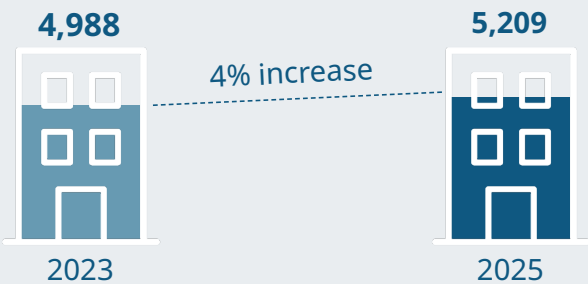

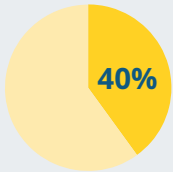


11,637 people were identified as experiencing homelessness, compared with 11,352 in 2023.

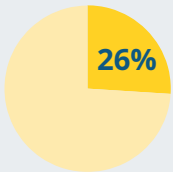
Number of People in Emergency Shelters

26% of respondents identified as having an acquired brain injury.



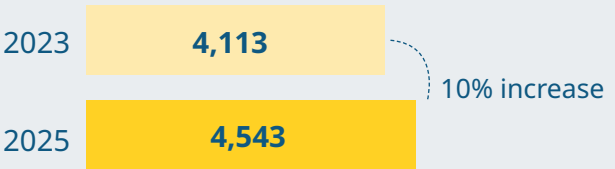

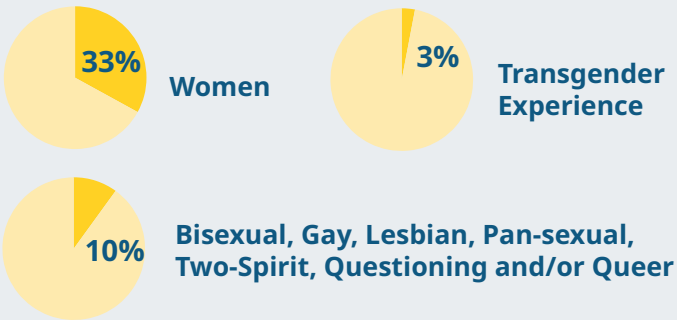

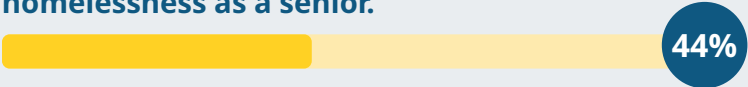

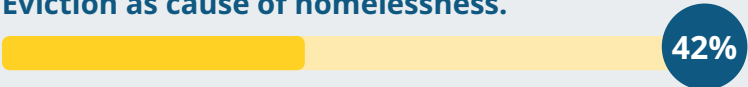

Introduction and How to Interpret and Use This Report

This Report summarizes findings from 32 homeless counts conducted in communities across British Columbia.

Sources of data include:

- Twenty (20) homeless counts funded by the Provincial government through *BC Housing*¹, conducted over 24-hour periods in each community between March 1st and May 1st, 2025;
- Ten homeless counts funded by the Federal government through *Reaching Home: Canada's Homelessness Strategy*², conducted over 24-hour periods in each community between October 8th, 2024 and March 26th, 2025;
- Two independently funded homeless counts;
- BC Housing-funded shelter, transition house, and safe home data for the night of March 11th, 2025 (provided by BC Housing) from 36 B.C. communities that were not involved in a homeless count.

Point-in-Time Homeless Counts (PiT counts; homeless counts, counts) have previously taken place in communities across British Columbia in 2018, 2020/21, and 2023. Homeless counts are collaborative efforts by service providers, volunteers, and researchers to enumerate and survey the population experiencing homelessness in the province.

The limitations of this methodology are related to the timeframe over which the count is conducted, and the voluntary nature of the survey process. A more thorough discussion of limitations is made in Section 1.2 Methodological Limitations and Interpretation, but it is important to understand that this methodology results in a figure that is the absolute minimum number of people who are experiencing homelessness in a community on the specific 24-hour period of the count.

This Report also does not include people living in unstable tenancies and/or substandard housing. While not included within the homeless count, these situations account for a significant number of people experiencing housing vulnerability in the province.

This Report includes perspectives from the People with Lived and Living Experience (PWLLE) Advisory Committee on Homelessness. This is a committee supported by the Homelessness Services Association of BC (HSABC) and funded by the Ministry of Housing and Municipal Affairs. The role of the Committee is to ensure that the voices of those most impacted by homelessness inform provincial strategies, including the Belonging in BC homelessness plan. Established in 2024, its mandate centres on embedding lived experience perspectives into decision-making, promoting cultural safety and equity, and advising on systemic issues affecting homelessness in BC. By creating space for underrepresented communities, including Indigenous peoples, racialized groups, and 2SLGBTQIA+ individuals the PWLLE Advisory Committee provides a unique perspective on inclusive and collaborative approaches. Key Findings

Below is a selection of key findings from Point-in-Time Homeless Counts conducted in fall 2024 and spring 2025 across BC.

11,637 people were identified as experiencing homelessness

Counts conducted in fall 2024 and spring 2025 across BC include people experiencing homelessness who were enumerated by either completing a survey or being counted in a shelter, transition house, safe home, hospital, correctional facility, or detox centre.

Unsheltered homelessness increased in communities that conducted counts in 2023

5,246 individuals were identified as experiencing unsheltered homelessness by the Counts.

When comparing only those communities that conducted counts in both 2023 and 2024/2025, the total number of those who were unsheltered increased by 10% (4,113 in 2023, compared to 4,543 in 2024/2025).

People staying in an Emergency Shelter increased compared to 2023

5,209 people were staying in temporary or permanent emergency shelters in the province. This is a 4% increase from 4,988 people in 2023.

1,182 people were staying in a sheltered location other than a temporary or permanent emergency shelter. This includes transition houses, youth safe houses, EWR shelters, or healthcare facilities or local holding cells temporarily with no fixed address. This is a 34% decrease from 1,785 people in these locations in 2023.

A majority of people experiencing homelessness are established residents of the community where they were counted

Sixty-seven percent (67%) of people have lived for five years or more in the community where they completed a survey.

Majority of individuals surveyed have been experiencing homelessness for over one year

Seventy-three percent (73%) of respondents reported that their current experience of homelessness was one year or more.

Individuals who identify as Indigenous continue to be overrepresented in homelessness

Consistent with all Point-in-Time Counts conducted to date in B.C., people who identify as Indigenous are overrepresented. Forty percent (40%) of respondents identified as Indigenous. This is the same percentage who identified as Indigenous in the 2023 Count.

Youth and seniors continue to experience homelessness

Seven percent (7%) of respondents were youth (under the age of 25), and twenty-two (22%) were seniors (55 years or older). It is important to note that these age groups are more likely to be experiencing hidden homelessness, and less likely to be encountered on the day of the count.

Almost half of youth have experienced homelessness for one year or more

Forty-eight percent (48%) of respondents who were youth under the age of 25 identified as experiencing homelessness for one year or more.

A large proportion of seniors counted in this project had a first experience of homelessness in their senior years (55+)

Forty-four percent (44%) of respondents who were seniors reported having their first experience of homelessness while they were already a senior.

Many respondents identify as part of the 2SLGBTQIA+ Community

Two percent (2%) of respondents identified their gender as agender, non-binary, Two-Spirit, not listed and/or multiple responses. Three percent (3%) identified as having trans experience, and 10% identified their sexual orientation as asexual, bisexual, gay, lesbian, pan-sexual, Two-Spirit, questioning and/or queer.

Most respondents identified as having a range of health conditions

Almost three-quarters (72%) of respondents identified a substance use challenge, two-thirds (66%) a mental health challenge, and nearly half (46%) identified a challenge with a medical condition or illness. Forty percent (40%) of respondents identified as having a physical disability, one-third (34%) of respondents identified as having a challenge with their senses, and one-quarter (27%) of respondents identified as having an acquired brain injury that happened after birth.

Nicotine is the most common substance used

The most common substance respondents used was nicotine (73%), followed by stimulants (50%), cannabis (46%), opiates (44%), and alcohol (42%).

People who use substances are less likely to be in a shelter

Respondents in shelters were less likely to report using substances than those who were unsheltered. This is particularly pronounced for those who use stimulants, with 44% of those in shelters reporting using stimulants, compared with 56% of those staying out of shelters.

Tenants being evicted is a cause of homelessness

For the first time in this survey, respondents were asked specifically if their most recent experience of homelessness was related to an eviction. Forty-two percent (42%) of respondents responded that yes, their current experience of homelessness was related to an eviction. This includes both legal and illegal evictions. Of those who identified as being evicted, 33% identified as experiencing conflict, abuse, or discrimination by their landlord.

1. About This Report

This Report summarizes findings from 32 homeless counts conducted in communities across British Columbia in fall 2024 and spring 2025. It also includes data from BC Housing-funded shelter and transition houses/safe homes from 36 communities that were not involved in a homeless count.

The purpose of point-in-time homeless counts is to estimate the minimum number of people experiencing homelessness, obtain a demographic profile of those individuals, and identify trends that can be comparable to previous counts that used similar methodology.

1.1 Definition of Homelessness

For the purpose of the counts, an individual was defined as experiencing homelessness if they did not have a place of their own where they pay rent and can expect to stay for at least 30 days. This includes people who:

- **Stayed overnight on the Night of the Count** in shelters, including in homeless shelters, transition houses, safe homes, and youth safe houses; or people with no fixed address (NFA) staying temporarily in hospitals, holding cells, or detox facilities (defined as “sheltered”); or,
- **Were encountered by interviewers the Day of the Count**, and stayed in a place where they did not pay rent the previous night. This includes those staying outside in alleys, doorways, parkades, parks, vehicles, or temporarily at someone else’s place (couch surfing). This also includes people who were staying temporarily in hotels or being evicted within 30 days of the count with nowhere else to go.

Everyone who stayed in a shelter, transition house or safe home was enumerated by facility staff and confirmed with administrative data from BC Housing. Additionally, they had the option to complete a shelter survey (see Appendix C4) if they wanted. Those who were considered unsheltered completed screening questions (see Appendix C5) to ensure that individuals were not counted more than once and met the definition of homelessness.

1.2 Methodological Limitations and Interpretation

Some important considerations about the methodology:

- A PiT count represents the **minimum** number of people who are experiencing homelessness on a given day in the community. Participation is anonymous, confidential, and voluntary. This is one reason the PiT Count will be an undercount – if an individual does not want to participate, and was unsheltered, they are not counted.
- Participation relies on an individual being encountered; either staying in a transition house or shelter or approached on the day of the count by an interviewer. If they are not encountered or did not attend a community event to complete the survey, these individuals were not counted. Youth, seniors, Indigenous and racialized persons, newcomers to Canada, those in the 2SLGBTQQIA+ community, and those who do not access homelessness services are populations understood to be underrepresented in the count.
- Shelter capacity can change in a community after the count, including opening or closure of temporary or year-round shelter programs.
- The purpose of a PiT count is not intended to be a measure of everyone who experiences homelessness. By focusing on a single day, a count will not include some people who cycle in and out of homelessness.
- There are a variety of reasons why a count number will change over time in a community. These include changes in actual homelessness, supportive housing, and/or services available. Caution should be used when making comparisons across time or between communities without additional local context.

Weather conditions on the day of the count, community capacity including closing of shelters, reliance on volunteers, and local organizer capacity are some things that may affect PiT counts across time and communities. These variables are neither measured nor controllable. However, the PiT count methodology has remained relatively consistent since 2018, which adds value by enabling comparison of the trends over time.

Given these limitations, decision makers are encouraged to seek complimentary sources of data — such as reports from local service agencies — to corroborate the findings in this Report.

The definition and methodology used in this Report varies slightly from how some of the contributing communities report their results. This includes:

- Communities that used an extended period of time beyond the 24-hour period used in this Report, and/or included observed homelessness,
- Communities that included transitional housing in their definitions, and
- Communities that included provincially-run correctional centres.

1.2.1 Role of Project Co-Lead: BC Association of Aboriginal Friendship Centres

The BC Association of Aboriginal Friendship Centres (BCAAFC) was the co-lead on this project, both in the implementation of the 20 Provincially-funded Counts and the preparation of the results.

This role involved:

- Providing insight into and supporting the implementation of the Counts;
- Reviewing the survey, and the addition of new questions.
- Communicating with Nations on whose land counts took place, and Indigenous organizations in the count communities.
- Participating in data collection in four of the communities.
- Advising on the data analysis, interpretations and understanding the wider consequences.
- Providing review and feedback on the community results for the 20 Provincially-funded Counts and this Report on Homeless Counts in BC.

1.2.2 Survey Changes – 2025 Provincially-Funded Counts

In 2025, several changes to the survey were made after careful consideration, in order to align with Federally-funded Count requirements, input from count communities, and an interest in comparing results to previous counts. These changes include:

- Expanding the question related to health challenges to include “senses (seeing, hearing, etc.)”, and “acquired brain injury (happened after birth)”. In 2023, “do you identify as having an acquired brain injury that happened after birth?” had been a standalone question.
- In addition to asking about whether an individual identified as having a ‘substance use challenge,’ a separate question asked all participants if they used each of the following categories of substances: nicotine, cannabis, alcohol, opiates, and stimulants.
- Respondents were asked specifically if they were or were not on income assistance/Persons with Disability (PWD), before being asked if they had any other income as a separate question. In previous versions, income assistance/PWD was combined as a single income option respondents could choose.
- A new question asked if a respondent’s most recent housing loss was due to an eviction, in addition to the question that has been asked in previous counts of “what happened that caused you to lose your housing most recently?”

Additionally, BCAAFC made the following specific changes to the survey:

- Through multiple community consultations, a distinction-based identity question along with two service-use questions were added to the survey. These additions help assess both where people are accessing services and what services may be available to them.
- Removal of the question asking whether the participant had lived or generational experience of Residential School. Community partners felt that the benefit of asking this question did not outweigh the potential for harm. We already know that an alarming proportion of Indigenous peoples in Canada have lived or intergenerational Residential School experiences and that these experiences are deeply traumatic. Asking this directly in a brief enumeration context risked re-traumatization without offering meaningful support.

1.2.3. New Non-Count Report Data Sources: Corrections Data

Those in longer-term correctional facilities have not previously been enumerated. Thanks to a partnership between the Ministry of Housing and Municipal Affairs and B.C. Corrections, data was collected about the number of individuals in BC Corrections custody on March 11, 2025, who had no fixed address. As this data has not been historically used as part of reports on homeless counts in BC, it has been excluded from this Report's finding, but is available as Appendix E.

2. Summary of Provincial Findings

The following tables provide aggregate data from 32 Counts in communities across the province to create a provincial profile of people identified as experiencing homelessness. For the purposes of this Report, homelessness is defined as a person not having a place of their own where they pay rent. Some communities used different survey questions, and as a result, not all communities are included in each data table presented.

When discussing the total number of persons identified as experiencing homelessness using the PiT count methodology, it is important to highlight that it is always an undercount, and those who access services and shelters are more likely to be included than those who do not.

Every question is voluntary, and respondents can choose to skip any question they want or end the survey at any time. **The percentages represent those respondents who answered each question, not the total number of persons identified as experiencing homelessness.** See section 1.2 *Methodological Limitations and Interpretation* for more information.

In this Report, only percentages for demographic tables are presented to emphasize that these findings are only a sample of the population experiencing homelessness, not the entire population of persons experiencing homelessness.

“Don’t Know/No Answer” includes survey respondents who declined to answer a specific question, as well as people who did not answer the survey at all but were counted through occupancy data from shelter operators, hospitals, jails, and BC Housing. Some tables show large numbers of “Don’t Know/No Answer”. This is because surveys in the non-Provincially-funded counts may not have asked the specific question.

2.1 Total Number of Individuals Experiencing Homelessness

There are 11,637 people included in this Report as experiencing homelessness. This includes data from all 32 counts, as well as administrative shelter occupancy data from 36 communities that did not complete a count in 2024 or 2025.

6,391 were experiencing **Sheltered Homelessness**, and 5,246 were experiencing **Unsheltered Homelessness**.

1,182 people were staying in a sheltered location other than a temporary or permanent emergency shelter. This includes transition houses, youth safe houses, EWR shelters, or healthcare facilities or local holding cells temporarily with no fixed address. This is an 34% decrease from 1,785 people in these locations in 2023.

Based on BC Housing's occupancy data, temporary and permanent emergency shelters across the province had an occupancy of 93% on March 11th, 2025.

- Transition houses⁶ and youth safe houses⁷;
- EWR shelters⁸; and
- hospitals, local holding cells, or detox facilities temporarily with no fixed address (NFA).

Note: shelter capacity can change in a community after the Count, including opening or closure of temporary or year-round shelter programs.

Unsheltered homelessness includes those who stayed outside in alleys, doorways, parkades, parks and vehicles or those who were staying temporarily at someone else's place (couch surfing), a hotel without a place to return to, or with their parents in a temporary situation on the night of the Count. Note: the unsheltered count relies on finding individuals on the day of the Count. It may change due to a variety of factors (see Section 1.2 Methodological Limitations and Interpretation).

The PWLLE Advisory Committee shares that a person experiencing homelessness may not stay in a shelter for a variety of reasons. These can include individual experiences with shelters and other systems that can make an individual feel unsafe, and systemic barriers about shelter services offered. These include gendered spaces, pet policies, policies that prohibit couples staying together, belonging storage, safety of self and property, stay limits and others. So, it is not a matter of providing shelter spaces, *it is about providing shelter services that are trauma-informed and accessible.*

2.2 Who is Experiencing Homelessness

This section presents the results of the survey questions that ask about the respondents themselves. Only percentages are presented to emphasize that these findings represent a sample of the population experiencing homelessness, not the entire population of persons experiencing homelessness (see 1.2 Methodological Limitations and Interpretation).

2.2.1 INDIGENOUS IDENTITY

Presentation of Indigenous Data

Indigenous refers to the diverse cultures of First Nations, Métis, and Inuit people, regardless of whether they have legal status, or whether they are living in urban, rural, or remote areas. Some tables present the responses of Indigenous participants to non-Indigenous participants to illuminate the variances.

Consistent with every PiT count that has been conducted throughout B.C., Indigenous people are overrepresented. Forty percent (40%) of survey respondents who answered this question identified as Indigenous, with a higher percentage of unsheltered respondents (44%) than sheltered respondents (35%).

Disproportionate rates of homelessness are rooted in the ongoing structural violence of settler colonial society that creates hierarchical systems of privilege and oppression. Indigenous people in Canada face racism, discrimination, and the impacts of intergenerational trauma, which limit safe and equitable access to services making it easier to lose, and harder to acquire safe and stable housing.

2.2.2 GENDER IDENTITY

Among survey respondents, two-thirds (64%) identified as men, 33% identified as women, and 2% identified as agender, non-binary, Two-Spirit, not listed and/or multiple responses.

Information about the gender identity of people who experience homelessness can help to highlight the need for specific services and supports for people who identify as women, having transgender experience, or with another identity.

Respondents may skip questions or withhold information that could compromise their safety, particularly individuals from historically marginalized genders or other vulnerable populations who have faced discrimination and violence because of their identity.

The current climate of homelessness vilification increases the risk, making respondents feel exposed or judged when approached by volunteers. Even when sector workers or peers conduct surveys, pre-existing relationships can complicate disclosure.

2.2.3 TRANSGENDER EXPERIENCE

Respondents in some communities were asked a separate specific question about whether they identify as someone with transgender experience (meaning their gender identity is different than what they were assigned at birth). Three percent (3%) of respondents identified as having transgender experience.

2.2.5 AGE

Respondents were asked their age. While the majority are adults between 25 to 54 years (71%), more than one in five (22%) identified as a senior aged 55 years or older. Seniors represent twenty-eight percent (28%) of those in shelter, and may have different support needs than youth or adults.

2.2.6 YOUTH IN CARE

Respondents were asked if they had been in foster care, a youth group home, or an independent living agreement, with one-third (34%) of respondents identifying that they had. This could have been in the past, or at the time of the count.

People who experienced homelessness for the first time while under the age of 19 were more likely to have lived in foster care, a youth group home, or on an Independent Living Agreement than those who experienced homelessness for the first time at age 19 or older.

Historically, the system has failed to provide services to people who age out of foster care¹², leading to a sizable number of people with former foster care experience who end up unhoused. More recently, the Government of BC has introduced new supports and resources to help youth transition out of care¹³.

2.2.7 RACIAL IDENTITY

Survey respondents were asked about their racial identity. 5% of respondents identified as Black, 2% as Latin American, and 2% as South Asian. Sixty one percent (61%) identified as white. “Not Listed” mostly includes respondents who chose to write in a cultural identity, rather than a racial identity. Respondents were able to provide multiple responses.

- **Difficulty accessing shelter or transitional housing due to eligibility criteria or capacity**

The transition from military life to homelessness in civilian society is complicated. Numerous health, social identity, and housing factors may play a role. It has been reported that 25% of Veterans in Canada rated their transition from military service to civilian life as difficult. These transitional difficulties may include mental illness and addiction, and the inability to maintain military behaviours exacerbates or causes homelessness.

2.3 Experiences of Homelessness

The following section provides the results of survey questions that ask about respondents' experiences with homelessness, homelessness services, and other aspects of their most recent experience of homelessness. Only percentages are presented to emphasize that these findings are only a sample of the population experiencing homelessness, not the entire population of persons experiencing homelessness.

2.3.1 WHERE UNSHELTERED RESPONDENTS STAYED, HIDDEN HOMELESSNESS, AND REPORTED SAFETY

Unsheltered survey respondents were asked where they stayed last night. Almost two thirds (64%) of survey respondents indicated an outdoor location including 43% unsheltered in a public place, 13% in an encampment and 8% in a makeshift shelter or tent.

Included in the Unsheltered number are individuals experiencing "hidden homelessness," defined as including those who are:

- (a) living temporarily with others, but without guarantee of continued residency or immediate prospects for accessing permanent housing (e.g. those staying at someone else's place, including with a parent or guardian temporarily); or
- (b) people accessing short term, temporary rental accommodations without security of tenure and with no access to a safe and permanent residence (e.g. self-funded motel/hotel).¹⁶

"Eighteen percent (18%) of unsheltered respondents indicated they stayed at someone else's place, sometimes referred to as "couch surfing". "Not listed" includes those who may have stayed in an overnight program that is not designated as a shelter or in their own place, but they will be evicted into homelessness in less than 30 days.

Those who stayed in indoor locations, such as organization-funded hotel rooms or at someone else's place, reported feeling safe there more often than those who stayed in outdoor locations.

2.3.2 LOCATIONS STAYED IN THE PAST YEAR

The experience of homelessness can change between “sheltered” and “unsheltered” for an individual over time. For at least one night in the past year, 70% of all respondents identified as having stayed in a homeless shelter, 55% reported staying outside, and 48% of people reported staying at someone else’s place.

Of sheltered respondents, 48% had stayed outside for at least one night in the previous year.

Of unsheltered respondents, more than half (54%) reported staying in a homeless shelter in the past year.

One-third (33%) of all respondents identified staying in an encampment in the previous year.

Respondents were instructed to “check all that apply” when answering this question, with many respondents selecting multiple response options.

Women and those who identify with a gender other than man or woman are more likely than men to have stayed at someone else's place in the past year. Youth were more likely to report having stayed at someone else's place and less likely to report having stayed in a homeless shelter in the past year than adults or seniors. Gender-diverse individuals experiencing homeless were more likely to sleep in public places, such as vehicles, transit stations, or abandoned buildings, compared to cisgender women (43% vs. 26%). Nearly a third also reported spending time in tents, encampments, or self-built shelters over the past year (31%). This pattern reflects higher exclusion rate due to explicit policies, such as being barred or restricted, combined with reporting feeling unsafe at much higher rates.

Additionally, Indigenous respondents were asked if they had accessed services from their Nation in the past year, with twenty-four percent (24%) reporting doing so.

People with disabilities are four times more likely to experience homelessness.

1 in 25 people with disabilities versus 1 in 100 people without disabilities have experienced homelessness.

They were more than two times more likely to experience hidden homelessness.

They were more likely to experience homelessness because of violence.

Of the people who experienced homelessness, 53% of people with disabilities said it was because of violence. This is compared to 36% of people without disabilities.

2.3.10 HEALTH AND DISABILITY

Survey respondents were asked a series of questions about their health. All health conditions were self-reported. Seventy-two percent (72%) of respondents identified a substance use challenge, sixty-six percent (66%) a mental health challenge, and forty-six percent (46%) identified a challenge with a medical condition or illness.

Forty percent (40%) of respondents identified as having a physical disability. One third (34%) of respondents identified as having a challenge with their senses, and one quarter (26%) of respondents identified as having an acquired brain injury that happened after birth.

Indigenous respondents reported a higher prevalence of health conditions, and higher rates of accessing health services (see Appendix A3, table 62).

Multimorbidity

Someone with “multimorbidity” refers to an individual who has a co-occurring chronic medical or mental health conditions. Multimorbidity often requires specialized treatment, and can cause additional barriers to accessing services.²⁴ Fifty-seven percent (57%) of respondents identified as having multimorbid challenges with mental health, substance use and/or an acquired brain injury.

2.3.11 SUBSTANCE USE

A new question in the Provincially-funded survey asked respondents to select from a list of substances they used. All respondents were asked this question regardless of the response to if they identified as having a substance use challenge. The list of substances included:

- Nicotine (e.g. cigarettes, vapes, nicotine replacement)
- Alcohol (e.g. beer, wine, spirits, non-beverage alcohols)
- Cannabis (e.g. smoked or edible cannabis or extracts)
- Opiates (e.g. heroin, fentanyl, morphine)
- Stimulants (e.g. methamphetamine, cocaine)

The most common substance respondents reported using was nicotine (73%), followed by stimulants, such as methamphetamine (50%), cannabis (46%), opiates (44%), and alcohol (42%). This suggests a further need for harm reduction and treatment programs for a range of substances.

For each substance category, more unsheltered respondents identified as using them than those who were in shelter on the night of the count.

In presenting this data about substances used, it is important to acknowledge the ongoing public health emergency and the “grief felt by families and friends remembering those who have died or had a permanent injury due to drug overdose.

"Overdose occurs when someone takes one or more drugs in a quantity or combination that exceeds what their body can handle. While street drugs often come to mind, overdose can happen with many different types of drugs, from alcohol to opioids, in all segments of the Canadian population, including those who take prescription drugs and those who use drugs recreationally.

"While Canada is, unfortunately, facing a range of issues related to drug-related poisoning, we are grappling with a steep increase in the number of deaths due to opioid overdoses among those who use drugs alone, men, youth, seniors, Indigenous peoples and those in correctional facilities. Last year, Canada lost almost 4,000 people to opioid overdoses—many linked to toxic drug supplies, fentanyl and other synthetic opioids. Worldwide, almost 200,000 people die prematurely due to drugs every year—the majority due to the use of opioids.

"In most cases, such deaths are avoidable."

2.3.12 SOURCES OF INCOME

Respondents were asked about their other sources of income. Respondents could indicate as many income sources as applicable. The most common responses other than income assistance (either basic Income Assistance or PWD) were a GST refund, informal employment, and receiving money from family or friends.

In some communities (Greater Vancouver, Princeton, and the 20 Provincially-funded Counts) respondents were asked specifically whether or not they were on income assistance. 3. CONCLUSION

Homeless Counts in B.C. identified 11,637 people experiencing homelessness in fall 2024 and spring 2025, a modest increase from the 11,352 identified by the 2023 Report on Homeless Counts in B.C.

While this total is relatively similar to the previous count, it is significant to note that the number of people experiencing unsheltered homelessness increased, up overall by 10% in communities that conducted counts in 2023. Similarly, the number of people staying in emergency shelters increased by 4% across the province (according to the Ministry of Housing and Municipal Affairs, the number of shelter spaces increased by 22% between November 2023 and November 2024)²⁶.

People from marginalized groups are more likely to experience homelessness:

- 40% of respondents identified as Indigenous, compared to six percent 6% of the Census population²⁷.
- 10% identified their sexual orientation as asexual, bisexual, gay, lesbian, pan-sexual, Two-Spirit, questioning and/or queer, compared to approximately 4% of the Canadian population aged 15 years and older. Two percent (2%) of respondents identified their gender as agender, non-binary, Two-Spirit, not listed and/or multiple responses, compared to approximately 0.33% of the population aged 15 years and over²⁸.
- 66% of respondents report having a mental health challenge (compared to 10% of Canadians aged 15 years and older²⁹), 40% report having a physical mobility challenge (compared to 11% of Canadians aged 15 years and older³⁰), and 26% report having an acquired brain injury (compared to 2% of the Canadian population live with a traumatic brain injury³¹).
- 55% of respondents who had experienced homelessness as a youth aged 19 or younger had also experienced foster care, a youth group home, or had an Independent Living Agreement with the Ministry of Children and Family Development.
- 69% of youth were experiencing unsheltered homelessness on the night of the counts, compared to 61% of adults and 47% of seniors.
- 44% of seniors reported staying at least one night outside or unsheltered in a public place over the past year and 24% reported staying in an encampment.

The experiences and demographics of people experiencing homelessness in the province are diverse. However, the root cause of homelessness “is both a complex societal issue and a deeply personal experience typically triggered by a combination of factors – individual, structural, and systemic”³². Every survey was conducted with someone who does not have a place of their own because of personal trauma and struggles, institutional barriers, and systemic failures that leave their needs unmet. By sharing these stories, the aim of this Report is to help shape our understanding of homelessness in BC and bring urgency to the need for increased availability of appropriate housing and supports to help people stay housed.

One of the strongest themes that came through during our discussions was that homelessness cannot be understood simply through numbers or categories. Behind every data point is a person navigating systems that are often fragmented, difficult to access, and shaped by stigma and structural inequities.

Many people experiencing homelessness face intersecting barriers poverty, trauma, racism, colonialism, and gaps in health and housing supports that make exiting homelessness far more complex than public narratives often acknowledge.

Appendix C1 Point-In-Time Methodology for Provincially-Funded Communities

Overnight Shelter Count

The shelter counts took place on the evening before the daytime count in each of the 20 Provincially-funded count communities. Shelter counts provided information about people staying overnight in emergency shelters, Extreme Weather Response shelters (EWRs), transition houses, safe homes, youth safe houses, detox facilities, and for people with no fixed address (NFA) staying in hospitals and jails. To ensure that the count was as accurate as possible, each emergency shelter, transition house, safe home, youth safe house, and detox facility was asked to complete a shelter enumeration form to record the total number of people who stayed overnight at the site.

While not all people staying at a shelter filled out a survey; everyone staying in a shelter facility was enumerated. Police provided a tally of people with no fixed address staying in jail cells on the night of the count in each community and health authorities participated by submitting tallies of people with no fixed address staying at each community's hospital or health centre on the night of the count.

Daytime Count

On the day of the count, the daytime count began early in the morning in each community and continued until the evening. The daytime count focused on conducting surveys with people in public areas or locations where people experiencing homelessness were likely to be, including streets, alleys, parks, and places where services and programs were available, such as meal programs and drop-in centres.

HSABC supported Local Coordinators to identify these locations in each community through route mapping exercises in partnership with community agencies, outreach workers, and service providers prior to the count. Survey administrators were assigned to specific locations and given maps and/or instructions to approach individuals and conduct a survey. In many communities, peers were provided training and survey materials and encouraged to connect with people they knew who were experiencing homelessness, rather than being assigned a formal route.

Each survey respondent was asked a series of screening questions and screened out if they either indicated that they had already answered the survey, or if they had a place of their own where they paid rent and could expect to stay for at least 30 days. As part of the street survey, respondents were also asked where they had stayed the previous night. If an individual indicated they stayed in a shelter, safe house, or transition house the night before, but they had not completed a survey, they were able to complete one. The surveys for these individuals were then grouped with other sheltered respondents and not included as part of the unsheltered number. When an individual indicated they had already filled out a survey, the survey was stopped and screened out. People who reported staying at someone else's place on the night of the count, but did not have a place where they paid rent, were considered unsheltered and were screened in.

Appendix C2 Twenty Provincially-Funded Count Communities

HSABC and BCAAFC implemented the counts in each of the twenty Provincially-funded Count communities in collaboration with a Local Coordinator. Across all communities, the methodology was applied consistently with respect to the approach, definitions, purpose, and structure of the interview questions. This consistent methodology worked to ensure accurate data collection. In all communities, HSABC and BCAAFC worked with Local Coordinators to:

- Engage survey administrators from community agencies and individuals with lived expertise and living experience of homelessness. Persons with this experience of homelessness were paid an honorarium for their time planning and implementing the count.
- Collaborate with Local Coordinators and the community to understand community context and priorities in implementing the count.
- Engage community agencies to:
 - Map street walking routes for the day of the count;
 - Be a “drop site” where individuals could complete a survey as part of their normal visit to the agency;
 - Spread the word about the count date and its importance through posters and leaflets; and/or
 - Host a “magnet” event that provided food or other services where the surveys could be completed. The events, generally lasting a few hours, were advertised well in advance and usually included a meal, and support. Hosting an event can increase the likelihood of someone experiencing homelessness completing a survey, especially someone who might otherwise not be surveyed through a sheltered or unsheltered count.
- Provide consistent training for survey administrators.
- Ensure local knowledge and experience with homeless counts was included in the planning and process of developing and implementing the count.
- Be in the community on the day of the count to support the Local Coordinator, survey administrators, and local agencies. HSABC had at least one staff member in all Provincially-funded count communities on the day of their count.

Background: BC Housing, the Ministry of Housing and Municipal Affairs, and the Homelessness Services Association of BC collaborate to produce Point-in-Time Homeless Counts (PiT Counts) for communities across BC. The Performance, Research and Evaluation unit at BC Corrections participated in the PiT Count through a review of administrative data including residential address files for all individuals in custody throughout the province. The count was based on all individuals in provincial custody on the PiT date (as of 11:59 pm) whose primary address in BC Corrections case management system (CORNET), and where the address at the time of analysis suggested a precarious or uncertain housing situation upon release.

Precarious or uncertain housing situation status will for the most part be identified with 'NFA' being listed in the address field (and various iterations of NFA). The remainder will be identified with the following key words/phrases: A commonly used name of a shelter/TC/transition housing such as ("Our Place", "Salvation Army"), "Shelter" "Campground", "Camping", "Camp", "Tent" "DTE" (commonly used to refer to Downtown East Side), ("Treatment Centre", "TC"), "Church", "Couch Surfing", "Temporary", "Staying with friend". Note that individuals listed as living with family members and without any reference to the arrangement being temporary are not counted here.

Results: Of the 2,376 individuals in custody on March 11, 2025, there was a successful extraction of address records from CORNET for approximately 99% (n=2,352).

Those in longer-term correctional facilities have not previously been enumerated. This data is provided thanks to a partnership between the Ministry of Housing and Municipal Affairs and B.C. Corrections. As this data has not been historically used as part of reports on homeless counts in BC, it has been excluded from this Report's findings.
