

Businesses and non-profits that provide food, shelter, social, and support services, and other necessities of life for economically disadvantaged or otherwise vulnerable individuals.

#### Measures You Can Take

- Work at Home
- Reduced Hours
- Rotating Shifts
- Flexible Shifts
- Paid Leave entitlements
- El-supported Leaves of Absence
- Temporary Lay-offs

#### Changes to Employment Standards Act

- COVID-related leave
- Protection from termination
- Re-employment guarantee
- Leave is indefinite
- Service continuous
- Medical notes not required
- Notice ineffective
- Retroactive to January 27/20

#### WorkSafe BC

- OHS legislation applies
- Must be work-related
- Employers have a legal duty to take all reasonable care to ensure health and safety of workers
- Flexible duty that may vary from workplace to workplace and from worker to worker
- Work Refusals
- Protect **vulnerable** workers
- WorkSafeBC COVID-19 Updates
- WorkSafeBC Prevention Line

#### Canada's COVID-19 Economic Response Plan \$27 Billion to support workers & businesses \$55 Billion in tax deferrals

Canada's COVID-19 Emergency Response Plan

#### **BC** Assistance

- \$5 Billion committed
- \$2.8 B on people & services
- \$2.2 B on business economic recovery
- Includes direct payments and deferment of payments

BC Government will continue to provide funding to non-profit agencies and child-care providers, even if they are closed or have had to reduce their hours of operations.
